

REPORT ON THE WORK OF THE CENTER FOR DEMOCRACY FOUNDATION IN 2022

Introduction

During 2022, the Center for Democracy Foundation acted in accordance with its program portfolio, which consists of three basic programs: advocating for the European integration of Serbia, encouraging public dialogue and encouraging sustainable economic and social development, including the promotion of economic and social rights.

During 2022, the CDF implemented six projects, actively acted within the framework of the National Convention on the European Union (NCEU), within the framework of the the European Association for Local Democracy, the Foundation for European Progressive Studies (FEPS) and the UN Global Compact.

The CDF has submitted more than 10 project applications to the published tenders of USAID, European Commission and the EU Delegation in Serbia (3 project proposals), the Embassy of Canada and others. In the development of project applications, the CDF acted as the lead partner, together with partner organizations from Serbia, the Western Balkans region and the European Union.

The work of the Foundation is supported by the long-term donors such as Olof Palme International Center, the Open Society Foundation, Deutsche Gesellschaft für Internationale Zusammenarbeit GmbH (GiZ), The Swiss Agency for Development and Cooperation (SDC), the European Commission, the Friedrich Ebert Foundation, and cooperation has been established with new donors - United Nations Population Fund (UNFPA).

Established Goals

From the strategic development plan extended to 2022 (due to the Covid19 pandemic, the duration of the strategic plan was extended), work on the realization of the goals continued:

- ❖ Strategic direction 1: Improve development programs for different groups of users and the community, based on practical research, within the framework of local, regional and national strategies and accession negotiations with the EU, in accordance with EU standards, supporting cross-sectoral cooperation
 - ♣ Strategic objective 1: Create a platform for public dialogue on strategic and current state and social issues
 - Strategic objective 2: Improve the legal framework and system of protection of economic, social, cultural and labor rights
 - ♣ Strategic objective 3: Advocate European values, democratic procedures and the rule of law for the development of an independent judiciary, parliamentary oversight, efficient and responsive public administration and local self-government, and contribution to the fight against corruption and good governance of public resources
- Strategic direction 2: Develop open communication with the environment and encourage the exchange of knowledge and experiences
 - Strategic objective 1: Increase the recognition of the Foundation in the public
 - ♣ Strategic objective 2: Strengthen the joint capacities of relevant social actors
- Strategic direction 3: Improve the internal capacities of the organization in accordance with the mission, respecting the principles of permanent learning, the agreed value system and the image of a reliable partner to domestic and international organizations
 - ♣ Strategic objective 1: Harmonize internal human resources with the agreed directions of development of the organization and its activities
 - ♣ Strategic objective 2: Establish procedures that ensure optimal use of the organization's resources and effectiveness in work
 - ♣ Strategic objective 3: Put the resources of the founders and users of the program into the function of organizational development
 - ♣ Strategic objective 4: Develop a network of Foundation collaborators who will strengthen the capacities and reputation of the organization

The objectives were mostly achieved during the period of implementation of the plan, so it is necessary to proceed with the creation of a new development plan by the end of 2022.

CDF 2022 in numbers:

- Activities realized in Pirot, Zaječar, Knjaževac, Niš, Leskovac, Požega, Užice, Novi Sad, Zrenjanin, Apatin, Novi Pazar, Veliko Gradište and others.
- ♣ Three trainings were held for local self-government in the field of development planning and three trainings for representatives of marginalized groups for the protection of rights on the labor market.
- ♣ More than 20 debates and workshops were held with the participation of more than 1000 citizens in vivo and online.
- More than 50 external associates were engaged in the activities of the Foundation.
- 24 blogs, analyses, public policy proposals were published.
- ♣ During 2022, the Foundation had very good media representation 148 articles were published in print and online media about FCD activities.

Project Activities

Labour Rights are Our Rights

Social and Economic Rights and Sustainable Development is the continuation of the project **Labour Rights are Our Rights,** implemented by the Center for Democracy Foundation in 2022 with the support of the Olof Palme International Center. In its strategy for the Western Balkans, Olof Palme International Center determined the problem of changes and implementation of labour legislation as one of the priorities, then cooperation of civil society organizations with trade unions, and networking of civil society organizations dealing with these issues. The Center for Democracy is perceived as one of the key partners in Serbia and the Western Balkans region. The overall objective of the project **Social and Economic Rights and Sustainable Development** is the promotion of social and economic rights within the context of EU-oriented reforms in Serbia. This is done through the empowerment of the citizenry in terms of their rights, strengthening trade union and CSO capacities to participate in creating and monitoring public policy in line with the law. This is a human rights-based approach with the expanded collaboration of key actors, which leads to stronger networks at the national and local levels.

Main activities in 2022:

Debate: Labour and Other Social Rights in the Upcoming Election Programmes

Within the framework of the Social and Economic Rights and Sustainable Development project, the Center for Democracy Foundation, with the support of the Olof Palme International Center, organised a public debate on the following topic: Labour and Other Social Rights in the Upcoming Election Programmes

(more than 60 participants live and online). Together Toward Achieving the Decent Work Standard for Women and Sustainable Development Workshop

On 27 June 2022, the Center for Democracy Foundation organised a workshop entitled **Together Toward Achieving the Decent Work Standard for Women and Sustainable Development** within the framework of the Socioeconomic Rights and Sustainable Development project. The workshop dealt with the challenges and issues faced by women in the labour market from the viewpoint of women's organisations and the possibility of working with trade unions in overcoming these challenges and the application of the Regulatory Gender Test, in cooperation with National Public Policy Secretariat (NPPS).²

Workshop: Together toward Decent Work Standards for LGBT+ People and Sustainable Development

The following workshop: Together to the Decent Work Standards for LGBT+ People and Sustainable Development was organised by the Center for Democracy Foundation, within the framework of the Socioeconomic Rights and Sustainable Development project (15 participants). The workshop was organised at the Miljenko Dereta venue in Belgrade through the programme: Belgrade EuroPride 2022.

The workshop dealt with the challenges and issues facing LGBT+ people on the labour market from the viewpoint of civil society organisations (CSOs) and the possibility of working with trade unions in overcoming these challenges. The aim of the workshop was to establish a better sense of understanding

The non-governmental organizations, committed to European integration of Serbia, every year organize the public reading of the Report with aim to improve citizens` understanding of the key findings of the EU on the progress Serbia has made in previous year on its EU path. The most significant findings of the European Commission were presented at the public reading. Various areas were examined and the reports of other countries of the Western Balkans were compared with the Serbia Report. Organisations

that have spent years dedicated to Serbia's accession to the EU gave their recommendations on how to improve the process.¹⁰

Analyzes and blogs

As part of the projects, During 2022, 4 analyzes and 6 author's blogs were published as a part of the project activities.

Online campaign

During December 2022, an online campaign was conducted on the topic of the advantages of the new model of the Labor Law compared to the current Labour Law. Through this activity, through animated videos, comparative solutions related to the employment relationship, working hours and working on Sundays, minimum and guaranteed wages, termination of employment contracts and organizing a strike were presented to the citizens.¹³

Annual conference "Economic and Energy Crisis, Labour Market and Decent Work in Serbia"

On Thursday, December 15, 2022, Center for Democracy Foundation organized the Annual conference "Economic and Energy Crisis, Labour Market and Decent Work in Serbia" within the framework of the "Social and Economic Rights and Sustainable Development" project (108 participants live and online). During this conference, we discussed economic and social rights, with the focus on labour rights, decent work and economic growth. This year, a special focus was on the impact of the economic and energy crisis on the world of labour, economic and social rights and the Sustainable Development Goals, as well as on the just transition strategy and its impact on economic and social rights.

CDF CONTRIBUTION TO THE 2030 AGENDA / SUSTAINABLE DEVELOPMENT GOALS

The Center for Democracy Foundation is one of the partners in the **Sustainable Development Goals for All Platform** project, within which, together with the Ana and Vlade Divac Foundation, works on spreading knowledge, involving all key actors, and proposing priorities and policies for several important sustainable development goals: Goal 1 - No poverty, 2 - Zero hunger, 3 - Good health and well-being, 4 - Quality education, 5 - Gender equality.

The Sustainable Development Goals for All Platform project is a three-year project started at the beginning of 2020. Project activities are implemented within three pillars - social, economic and environmental protection. The first, social pillar is coordinated by the Ana and Vlade Divac Foundation with the Center for Democracy Foundation, the second pillar is covered by CEVES, and the third pillar is coordinated by the Belgrade Open School with the Belgrade Fund for Political Excellence. The project is supported by GiZ (Deutsche Gesellschaft für Internationale Zusammenarbeit) and the Swiss Agency for Development and Cooperation (SDC).

One of the key messages was that preparing for economic and social shifts associated with an ageing population is key to achieving 2030 Agenda. It was also emphasized that ageing should be seen as a horizontal issue, reflected in multiple SDGs: poverty eradication, sound health, gender equality, economic growth and decent work, reducing inequality, sustainable cities, etc.¹⁶

Public debate: Contribution of the Economic Reforms Programme (ERP) to Achieving SDG 5 - Gender Equality

On 6 April 2022, the Center for Democracy Foundation organized a public debate entitled: **Contribution of the Economic Reforms Programme (ERP) to Achieving SDG 5 - Gender Equality**. The debate was part of the Thematic Group – Achieve Gender Equality and Empower All Women and Girls established within the SDGs for All Platform.

Introductory speakers at the debate were: Sanja Mešanović (Deputy Director of the Public Policy Secretariat), Marijana Pajvančić (Professor and activist), Sarita Bradaš (Center for Democracy Foundation), Nevena Petrušić (Professor and President of the Women's Research Center in Niš), Čedanka Andrić (President of the United Branch Trade Union Independence), Aleksandra Vladisavljević (Consultant and Gender Responsive Policies and Budgeting Expert), Lana Hadži-Niković (CEVES, Project Coordinator for SDGs for All Platform), Nataša Vučković (Center for Democracy Foundation) and Ivona Gvozdenović (Ana and Vlade Divac Foundation). Gordana Čomić, Minister (Ministry of Human and Minority Rights and Social Dialogue), Ljiljana Lučić (former State Secretary at the Ministry of Labour, Employment, Veteran and Social Affairs), Nada Lazić (Ministry of Human and Minority Rights and Social Dialogue), Milica Glišić (Citizens' Association Atina) and others, also took part in the discussion.

During the debate, participants analyzed the extent to which the gender mainstreaming principles were integrated into the ERP, that is: to what extent has gender mainstreaming been integrated into structural reforms and has the impact of such reforms been envisaged and well thought out, in terms of gender inequality and discrimination?¹⁷

Public debate: To What Extent Does Energy Saving Contribute to the Sustainable Development Goals

The Center for Democracy Foundation organised a public debate: **To What Extent Does Energy Saving Contribute to the Sustainable Development Goals**, on 14 April 2022, as part of the SDGs for ALL Platform's thematic group on poverty. The starting point for the debate was the **Energy Poverty analysis**¹⁹, drafted by **Prof. Ksenija Petovar, PhD**, which proposes future actions to be taken within this domain.

The purpose of the debate was to initiate a broad dialogue on energy poverty and discuss ways how to tackle this phenomenon and protect most vulnerable consumers.²⁰



Public debate: Child Poverty and the 2030 Agenda

The Center for Democracy Foundation organised the following debate: **Child Poverty and the 2030 Agenda** on May 23. The public debate was organised as an activity of the Advisory Thematic Group – Eradicating Poverty within the SDGs for ALL Platform. The debate included a presentation of the **Child Poverty and the 2030 Agenda analysis²¹**, drafted by the **Associate Prof. Marina Savković, PhD**, containing recommendations aiming to contribute to the eradication of child poverty.

The introductory speakers included **Prof. Slavica Đukić Dejanović, PhD** (Special Advisor to the Prime Minister on the 2030 Agenda), **Biljana Mladenović** (UNICEF), **Jovana Božičković** (KOMS), **Associate Prof. Marina Savković, PhD** (CDF), **Jelena Tanasijević, PhD** (SOS Children's Villages), **Prof. Nevena Vučković-Šahović, PhD** (UN Children's Rights Committee member 2003-2009; Child Rights Centre) and **Nataša Vučković** (CDF). The debate also brought together the reprsentatives of the Ministry of Human and Minority Rights and Social Dialogue, Ministry of Youth and Sports, Ministry of Labour, Employment,

Veteran and Social Affairs, the Office of the Commissioner for Information of Public Importance and Personal Data Protection, Statistical Office of the Republic of Serbia, Office of the Commissioner for the Protection of Equality, Ministry of Trade, Tourism and Telecommunications, National Employment Service Serbia, civil society organizations, researchers, Red Cross, SCTM, social services centres and trade unions. The discussion highlighted that child poverty impacts those who are most vulnerable in society and produces seriouslong-term effects on the overall development of society.²²



Training "Sustainable Development Goals at the local level" in Zajecar, Pirot and Apatin

The Center for Democracy Foundation, as part of the social pillar of the "SDGs for ALL" Platform, organized training sessions in **Zajecar**, **Pirot** and **Apatin** on the topic "Sustainable Development Goals at the local level".

Representatives of local self-government, local CSO community, educational institutions, trade unions, business and media participated in the training conducted by experts from the Center for Democracy Foundation and the Public Policy Secretariat of the Republic of Serbia. The topics of the training included the 2030 Agenda implementation at the local level; SDGs and the process of European integration, advocacy and communication; Law on Planning System of the Republic of Serbia; alignment of local development plans with SDGs.²³

Public debate: Elderly poverty in Serbia and Agenda 2030

The Center for Democracy Foundation organised a debate on **Elderly poverty in Serbia and Agenda 2030** on July 13. The public debate was organised as an activity of the Advisory Thematic Group – Eradicating Poverty within the SDGs for ALL Platform. The starting point for the debate was the **Elderly poverty in Serbia and Agenda 2030 analysis²⁴**, drafted by **Lidija Kuzmanov**, with recommendations contributing to the eradication of poverty among the ageing population.

Social Policy), Nadežda Satarić (Amity Association), Nataša Todorović (Red Cross of Serbia), Lidija Kuzmanov (freelance consultant), Irena Cerović (UNDP Serbia), Nataša Vučković (Center for Democracy Foundation), Ivona Gvozdenović (Ana and Vlade Divac Foundation), Sarita Bradaš (FCD), Ljiljana Lučić (former State Secretary at the Ministry of Labour, Employment, Veteran and Social Affairs) and others. The debate emphasised that the 2030 Agenda ranks the eradication of poverty as one of the most urgent priorities. Despite the fact that Serbia has taken significant steps to reduce the risk of poverty and the risk of poverty or social exclusion, the population of 65 years of age and older is the only age category which is moving away from the goal, with poverty increasing among this category over the past 5-year period.²⁵



Thematic Groups meeting within the Social Pillar of the "Sustainable Development for All" Platform

The Thematic Groups meeting "Achieve Gender Equality and Empower All Women and Girls" and "Eradicating of Poverty", established within the Social Pillar of the "Sustainable Development for All" Platform project, was held on July 13, 2022 in Belgrade.

The content of the work of the Thematic Groups was aimed at analyzing, monitoring and reporting on legal, strategic and other relevant conditions for the implementation of SDGs, for the relevant thematic area. Members of the Thematic Groups had the opportunity to participate independently or in a team in the preparation and presentation of analyses, recommendations, as well as in workshops and public debates where the work of the groups was presented to relevant actors.²⁶

At the invitation of the partners on the Platform, the following activities were carried out:

Roundtable was organized on June 2, 2022 in Zaječar on the topic "Sustainable Development Goals at the local level contribution of gender equality to sustainable development" Sarita Bradaš presented the findings of the analysis on the implementation of local policies in Zaječar, at the invitation of the Ana and Vlade Divac Foundation.

The main goals of the project are to contribute to inequality and poverty reduction, the protection of social rights, and mitigation of the negative social effects of the Covid-19 crisis, by advocating for fair socio-economic policies and creating a supportive environment in which the citizenry is included in dialogue concerning public policies. This project is in fact the third phase of the project: Policies Beneficial to All - Public Participation in Monitoring Reforms Toward Better Public Policies and Sustainable Socio-economic Development³⁵, implemented with the support of the Open Society Foundation Serbia.

Debate: Green Jobs in Serbia

On 20 April 2022, the Center for Democracy Foundation organised the debate: **Green Jobs in Serbia**, in collaboration with the Friedrich Ebert Foundation (more than 40 participants live and online). Partaking in the discussion were: **Jovan Protić** (International Labour Organization), **Aleksandra Lakić** (Zajedničko Association), **Nataša Đereg**, CEKOR; **Melanija Lojpur** (Association of Independent Trade Unions Serbia); **Nebojša Atanacković**, National Employment Service Serbia. The discussion was moderated by: **Petrica Đaković**, journalist.

It was pointed out in the conversation that green jobs, according to international definition, must contribute to the preservation or improvement of environmental protection. They must also include a

labour/legal component. Green jobs must be decent jobs that provide equal access to rights for all. They must include decent wages, decent working hours, and are jobs where employees are registered, with paid social benefits and contributions, and jobs that are safe to perform. The democratisation of the economy is a prerequisite for green transformation. It is a positive thing to talk about green jobs and it is good that we have opened Cluster 4 in the process of European integration. Serbia is now drafting an important strategic document - the National Climate and Energy Plan, which will outline Serbia's future energy mix.⁴¹



Artificial Intelligence and the World of Work in Serbia debate

On 23 June 2022, in cooperation with the Friedrich Ebert Foundation, the Center for Democracy Foundation organised a debate entitled **Artificial Intelligence and the World of Work in Serbia** (60 participants live and online). Introductory speakers at the debate were: **Ljubica Ilić Vojnović**, Ministry of Education, Science and Technological Development, Department of Technological Development, the Transfer of Tehnologies and Innovation Systems; **Vladimir Lalošević**, Serbian Association of Employers, President of the Union of Employers of Vojvodina; **Branka Anđelković**, Public Policy Research Centre; **Darko Božičić**, Assistant at the Faculty of Law of Novi Sad; **Tijana Nikolić**, Artificial Intelligence Specialist at Sogeti, Netherlands. The discussion was moderated by **Petrica Đaković**, journalist.

The conclusion drawn during the debate was that AI has the potential to completely transform society and the way we view the world. The swift social changes, resulting from the development of new technologies in the 21st century, are unprecedented in human history. New technologies have the potential to completely change the way all of society will function in just a couple of years. This includes traffic, market conditions, communication which may create new needs and lifestyle. AI cannot be viewed as a phenomenon just at the regional level, it is necessary to include global trends, which are constantly changing and developing. Many countries recognise the need to define an overall action plan and strategic and legislative frameworks to formulate clearly defined AI development goals. Given that man's resources are limited, AI may contribute to societal development, improving labour and work environments. Ethical guidelines are currently being prepared in Serbia, which will serve to regulate what it is that will help to ensure that the application of AI is in line with constitutional provisions, respecting the individual and society. It is important that AI be used for the good of humanity. It is necessary to maintain human autonomy and to keep the human being as the central figure.⁴²

Debate: Energy Crisis and the Position of the Poor in Serbia

On 21 September 2022, the Center for Democracy Foundation organised the debate: Energy Crisis and the Position of the Poor in Serbia, in collaboration with the Friedrich Ebert Foundation (70 participants live and online). Partaking in the discussion were: Zoran Ilić, Ministry of Mining and Energy; Zoran Ristić, United Branch Trade Union Independence; Danilo Ćurčić, A11 - Initiative for Economic and Social Rights; Ksenija Petovar, retired Professor at the faculties of Architecture and Geography; Goran Radosavljević, FEFA Institute; Iva Đinđić-Ćosić, Serbian Energy Law Association; Kirsten Schönefeld, Friedrich Ebert Foundation in Belgrade; Nataša Vučković, Center for Democracy Foundation. The discussion was moderated by Miloš Obradović, Journalist.

During the discussion it was emphasised that the energy crisis further adversely affects the state of poverty of those most vulnerable. The cost of energy that most of the population pay including the cost of fuel, have drastically increased and therefore the following question arises: how will those most vulnerable be able to pay? The energy crisis prompts us to consider how we can help these people. In regard to energy poverty, the Government must react and provide aid to the most vulnerable segments of the population to ensure they do not become victims of severe energy poverty over the coming winter. Accordingly, we have to adapt our social policy to this new situation. For an extensive period now, the Republic of Serbia has lacked a welfare strategy; a strategy to combat poverty. Furthermore, we have been waiting for ages for the adoption of the amendments to the Law on Welfare. Serbia needs to develop a systemic response to the issue of poverty.⁴³



Debate: Civic Activism as the Last Line in the Defence of Democracy

On 8 November 2022, the Center for Democracy Foundation organised the debate: Civic Activism as the Last Line in the Defence of Democracy, in collaboration with the Friedrich Ebert Foundation (with almost 80 participants live and online). The discussion was moderated by Antonela Riha, Journalist.

During the discussion, it was pointed out that in Serbia there is growing mistrust in state institutions, which goes hand in hand with the crisis facing the opposition. In our country professional journalism, the opposition, civic activism, are all prohibited. We don't have a country; we live in a pseudo-state; we no longer have a society, but rather, consist of rudimentary associations of people. The citizenry are sovereign holders of the right to influence the community in which they live. For civic activism to exist, people must be able to fight for their rights. Activism is not just an anti-political or anti-party act; it is the civic duty of everyone who lives here. In the overall erosion of rule of law, it is important to believe in the 'little guy' who wants to affect change in the local community. Without civic activism, there will be no change for the better. The citizenry is the key here.⁴⁴



"Extending Social Protection to families in Serbia with enhanced shock-responsiveness"

The Center for Democracy Foundation in cooperation with the United Nations Population Fund (UNFPA) conducted activities within the Joint United Nations Program "Extending Social Protection to families in Serbia with enhanced shock-responsiveness" through 12 focus groups with members of the most vulnerable groups in Niš, Leskovac, Požega, Užice, Zaječar, Knjaževac The project is supported by the Joint SDG Fund.

The documents "Report on Findings from the Focus Group Discussions" by Sarita Bradaš and the analysis of "Poverty Projection for Older Persons" by Lidija Kuzmanov were published.

Book of Recommendations of the National Convention on European Union 2021

In October 2022, the annual **"Book of Recommendations of the National Convention on the European Union 2021"** was published, which contains an overview and status of the Chapters, an overview of the situation and main evaluations, an evaluation of the previous recommendations of the NKEU, as well as recommendations for the year 2022. ⁴⁸

As part of the Book of Recommendations, the Center for Democracy Foundation prepared the recommendations of the Working Group for Chapters 2 (Free movement of workers) and 19 (Social policy and Employment).

National Convention on the European Union Welcomes Positive Developments Relative to Regional Cooperation

The **National Convention on the European Union (NCEU)** welcomes the positive developments seen in regional collaboration over the past months. One such example is today's gathering entitled Potential for Investments in Renewable Sources of Energy in the Western Balkans, where the focus is on regional cooperation regarding energy.

Today, the Intersectoral Working Group for Regional Cooperation discussed the results of the renewed Berlin Process, the summit of which was held early in November, as well as the results of other regional initiatives and organisations. Primarily, focus was on progress in implementing a Common Regional Market and the agreements concluded within the framework of the Open Balkan initiative. (...)

We expect continued reforms in the areas of democratisation, rule of law, fair energy transitions as well as the resolution of the remaining open issues to take place through the Berlin Process and other regional initiatives. The National Convention will support strengthening the role of civil society in improving regional cooperation.⁴⁹



Ending the Fragmentation of Labour Legislation and Application of the Law on Social Cards

The NCEU Working Group, which monitors Chapter 2 - Freedom of Movement for Workers and Chapter 19 - Social Policy and Employment, came to the following conclusions at its regular session held 30 November 2022: The Working Group is asking the Government of the Republic of Serbia and the National Assembly of the Republic of Serbia to end the fragmentation of labour legislation and for the Government to immediately begin working on drafting a new Employment Act. It is necessary to stop with the enforcement of the Law on Social Cards due to the poor results achieved at the very start of its application. Many socially vulnerable citizens were denied their right to financial social assistance and what's worse, this Law has resulted in the dehumanisation of social protection (...)⁵⁰





Plenary session of the National Convention on the EU

The plenary session of the National Convention on the European Union (NCEU) was held on December 21, 2022, in the National Assembly of the Republic of Serbia. Secretary General of the Center for Democracy Foundation and Coordinator of the Working Group for Chapters 2 (Free movement of workers) and 19 (Social policy and employment) and the Intersectoral Working Group for Regional Cooperation within the

framework of the NCEU, Nataša Vučković, indicated during the discussion that the red alarm for all of us represents a huge reduction in support of the Serbian citizens for the process of European integration, and the support of the citizens is very important, and she asked the Prime Minister of the Republic of Serbia and the Minister for European Integration whether the Government considered the consequences and whether it can ensure a uniform approach of the members of the Government in communicating about the EU values and reforms that should be take Serbia to the European Union.

SMELT – Skilling Marginalized people to Enter Labour Market

In 2022, the implementation of the two-year Erasmus+ project **SMELT – Skilling Marginalized people to Enter Labour Market** continued.

The project is being implemented in collaboration with 8 partners - Samarcanda società cooperativa sociale Onlus, Italy, Mosha Pijade Vocational Secondary School, Tetovo, Northern Macedonia, Synthesis Center for Research and Education Ltd, Cyprus, Asociación Mar Violeta, Spain, Sdruzhenie Yuni Partners, Bulgaria, European Association for Local Democracy (ALDA), France, Ecor International S.p.A., Italy and the Center for Democracy Foundation, Serbia.

The project aim is to improve the position of vulnerable groups, the homeless and migrants, in particular, and provide the skills they need to join the labour market. The project is financed by the European Commission through the Erasmus+ program.

As a part of the SMELT project, multilingual manuals (Easy Handbook) "How to find a job?" and a simple manual for supporting professional workers in working with marginalized groups were prepared and published.⁵¹

Transnational meeting of SMELT project partners

On October 17 and 18, 2022, representatives of partner organizations participating in the implementation of the Erasmus+ SMELT project held a transnational meeting in Gijon (Spain).



At the meeting, which was also attended by the representatives of the Center for Democracy Foundation, Dajana Ostojić and Andrea Trajković, the results so far and the activities carried out by the partners in this
