

## Introduction

In 2019 the Center for Democracy Foundation worked on the basis of the Strategic Development Plan (SDP) 2017-2019 and in accordance with the Action plan for 2019 documents. All the priorities, objectives, expected outcomes and activities were agreed upon these documents, on the level of Foundation's bodies and staff. The Action Plan for 2019 was adopted by the Management Board in February 2019. Accordingly, the Foundation's work continued to be streamlined through three major programmatic fields: Program 1 – EU integration of Serbia, rule of law and good governance, Program 2 – Employment, labour rights and social cohesion, and Program 3 – Public dialogue. Such a programme portfolio enables the Foundation to continuously focus on issues representing the major fields of its interests, as expressed in the Foundation's mission¹.

CDF continued its activities within the National Convention on the EU (NCEU), a 700 CSOs member umbrella organization in Serbia, engaged in monitoring the EU accession process. CDF is a member of the NCEU Programmatic Council as well as it coordinates the NCEU working group for the Chapter 2 (Free Movement of Workers) and the Chapter 19 (Social Policy and Employment).

In 2019 the Foundation developed new partnerships, strengthened its capacities and resources and further improved perspectives of its development in 2020. It established a project partnership with Ana and Vlade Divac Foundation. CDF together with Divac Foundation were selected to coordinate the Social Pillar at the SDGs for All - Society Wide Dialogue Platform in a three-year project funded by GiZ and Swiss Development Cooperation (SDC).

In 2019, CDF became a member of the EU network Association of Local Democracy Agencies (ALDA) with whom it has already cooperated since 2018 on the EU funded regional network project Regional Youth Compact for Europe. Cooperation continued with Foundation of European Progressive Studies (FEPS, Brussels) where CDF is an observing member and in UN Global Compact.

# Projects Implemented in 2019

#### REGIONAL YOUTH COMPACT FOR EUROPE

(RYCE, 2018-2021, funded by the EC and GMF/BTD)

This three-year regional project is a 14 partner's network coordinated by the CDF. The project aims to strengthen the capacity of CSOs and youth organizations in the Western Balkans for monitoring the reforms and for empowering them to advocate EU oriented reforms through structured dialogue between the civil society and the government. The project focuses on the rule of law and fundamental rights through a perspective of youth employment and social cohesion. Regional networking and strengthening of the Balkan Network for Local Democracy (BNLD) are seen as a tool to achieve the expected outcome.





#### During 2019 key project activities were:

Politeia, the Regional School for Youth Participation<sup>4</sup>, was organized in April 2019, in Danilovgrad, at the premises of the Regional School for Public Administration (ReSPA). The Curriculum was developed on the basis of the CDF experience in leading the three-year project Politiea School for Civil Society, which in Serbia alone was attended by nearly 2000 students (Politeia started in 1998) and was one of the well-known CDF brands, recognized by the students and by scholars. This activity of RYCE was announced with the slogan "Politeia Goes Regional" which accentuated its regional scope. One-week course was organized for 25 participants, selected through an open selection process, largely promoted on social networks all around the WB countries.

One of the RYCE activities was a thematic forum "Youth in the WB Region: towards the strategic responses for facing demographic challenges and labour market trends", which was organized in Pristina in November 2019. At the end of the Forum the participants adopted the Declaration, which was disseminated to media and social networks.

In order to further build the capacities of the members of the Balkan Network for Local Democracy a training was organized in Knjazevac in Serbia – Sharing Experience – enlarging thematic focus of the

Network", with more than 30 participants representing the organizations from all over the Western Balkans. The Network envisage to focus on monitoring and evaluation of public policies, evidence based advocacy on local level, local budgeting, youth policies...)





Two-day workshop "Rule of Law and Fundamental Right – why they are important for the youth and how they can contribute to monitoring of reforms" was held in Mostar, on March 25-26, 2019. More than 20 young people from Western Balkans participated in the series of workshops on the topic European Union, European values, standards and principles that every candidate country should incorporate during the accession process. The aim of this workshop was to empower youth for joining existing and creation of new thematic networks, which are focused on rule of law and fundamental rights, public administration reform, employment and social cohesion.

Discussion by participants about the situation on fundamental rights and rule of law in their countries made a significant contribution for gaining a wider picture about complete picture in the Western Balkans. International workshop "Rule of Law and Fundamental Rights" was organized by the Local Democracy Agency Mostar, which is one of the partners on this project. CDF Executive director Natasa Vuckovic was one of the trainers on the issue of the rule of law.

A study produced within the project Civil Society in the Western Balkans: Involvement in the EU Accession Negotiation and EU Integration Processes from Initiatives to a Structured Dialogue" aims to give to the Balkan countries which are involved in the accession process to the EU, numerous elements regarding the cooperation between authorities and CSOs which can help them in this procedure. Indeed the CSOs, with acquired expertise on specific fields, have the possibility to bring analyses and methods, which could be lacking in these countries. The future fulfillment of the chapters of the acquis 23 & 24 is precisely the chance to include civil society in this decision making process. For the general public, it

underlines the difficulties encountered by each country in this procedure but also shows the recent dynamics through progress and initiatives, which took place during the last years. The researches and interviews leaded in this study reveal finely where and how governmental actions would be the most impactful in the relations between CSO's and the authorities or between CSO's and the general public. Furthermore, the authors make a distinction on the one hand Serbia and Montenegro which are in an advanced phase of the EU integration and on the other hand North Macedonia, Albania, Kosovo and Bosnia and Herzegovina, which need more reforms in order to fulfill the European requirements. The study was conducted by a team of regional experts and translated in 4 languages, English, Macedonian, Albanian and BHS, all languages used in the project Regional Youth compact for Europe.

Seven bulletins were published, all in English, which shows the achievements of all project partners. <sup>6</sup>

# POLICIES FOR THE BENEFIT OF ALL: MEASURING SOCIAL IMPACT OF PUBLIC POLICIES THROUGH EMPOWERMENT AND INCLUSION OF CITIZENS

This is a one year project funded by the Open Society Foundation which started in mid-2019. It is based on the understanding that the social dimension of the process of the accession to the EU is crucial for the improvement of quality of life of citizens and for their continuing support for reforms and for Serbia's accession to the EU. Quality of education, public health, labour market, quality of work and good wages, social protection, quality of environment, reduction of inequalities, and access to justice are some of the priorities of the Serbian citizens.

This project aims to develop pilot methodology for measuring social impact of reforms by empowering citizens and include them in assessing the outcome of the implemented public policies. The CDF team and a peer reviewer from Slovenia developed the pilot methodology. It will be evaluated by the local CSOs and adapted to their needs for its application on local level. Manual is in preparation for local CSOs. At the end of the project a social scoreboard will be developed as an innovative tool for measuring social impact of reforms.

#### LABOUR RIGHTS ARE OUR RIGHTS

This three-year project funded by the International Center Olof Palme, has two main objectives. The first, to advocate for respect of labour rights in Serbia and to empower trade unions for more effective and innovative work, particularly in enlarging the membership base and responding to new challenges at the labour market. The project is based on the established cooperation of the CDF with the trade unions, which enables the CDF to create and foster new forms of collaboration with TU headquarters and local branches. CDF has signed Cooperation Agreements with both representative trade unions in Serbia – CATUS and TU Independence, and in November 2019 the CDF was awarded the recognition chart for continued cooperation by the TU Independence.





In 2019 the CDF published the annual report on the labour rights in Serbia which it presented at the annual conference Labour Rights are Our Rights, with the Commissioner for Protection of Equality as a key speaker, in December 2019.

"Who cares for the Older Workers" was a round table discussion organized in November 2019. CDF senior researcher Sarita Bradas, found no fresh survey, but according to the last available data from 2009 from the Republic's Statistics Office 1,3% of companies prefers employing workers aged 45 and older in comparison with 53,6% of companies preferring to employ workers of 25-45 years old.

"Trade Unions and the Young" was another round table organized in 2019 with participation of TU activists and youth organizations. How to attract new TU members among the young population and how to make young people more sensitized for their labour rights` protection were the key questions.

The workshop Gender and TU was organized in December 2019 where a paper Trade Unions and Gender Equality was presented. The participants from TU and from women organizations discussed key challenges for women at the labour market.

#### MONITORING ECONOMIC AND SOCIAL REFORMS

The CDF team members regularly prepared analysis and papers, published on the CDF website, social networks, other websites and portals (such as Pescanik) on economic and social development: Along the process of consultation of the EU Delegation with the civil society on the annual report on Serbia, the CDF provided an overview of the situation and challenges in the accession process. It also sent comments on the draft Economic Reform Programme of the Government of Serbia.

However, one of the key activity was the assessment of the draft Action plan for Chapter 19: in early January 2019, the NCEU Working Group for Chapter 19 presented its comments on the draft AP to the negotiating team of the Government of Serbia and to the Chief of the Negotiation Team, Tanja Miscevic. The opinions of the Working Group members were assembled and sent to the Government's negotiation team which responded without adopting any of the critical remarks. However, a new meeting was held in June 2019, which was an opportunity to map priorities.

In autumn 2019 the CDF prepared report and recommendations on chapters 2 and 19 prepared for the annual NCEU Recommendations Book (to be published in early 2020).

As one of the key players in the field of socio economic reforms, the CDF established a group of CSOs interested to prepare the analyses of the first draft of the Strategy for Social Protection and of the Draft Law on Social Protection in June 2019. The critical remarks were very serious and due an effective public campaign on social networks, the Government seems to have withdrawn the first draft of the Strategy.





#### DIALOGUE IN THE CENTER



Dialogue in the Center has marked its 12<sup>th</sup> year in 2019! Initiated in 2007 as a platform for dialogue among policy makers, civil society and citizens, under the title Democratic Political Forum (DPF), in cooperation with Friedrich Ebert Foundation, until 2019 more than 100 debates were organized with nearly 2000 participants from various fields of life – representatives of government, local municipalities, independent institutions, CSOs, academia and think tanks, as well as businesses, trade unions and business associations. Transcripts and video material is available for the previous debates on the CDF website. <sup>7</sup> The setting of the debates was changing in times: in the first seven years, the debates were organized in cooperation with the National Bank of Serbia which donated its conference hall. Since 2014 the debates took place in Media Center or, as of 2018, in Envoy Conference Center. Visibility of the debates was rather high as they were filmed and transmitted at the B92 Info Channel, often with repeated broadcasting. In 2017, marking the 10<sup>th</sup> anniversary of the project, the name was changed into Dialogue in the Center.

#### PUBLIC READING OF THE EC REPORT ON SERBIA


The project was designed with the partner European Western Balkans on the ground of the identified need to present the EC Report on Serbia to the citizens and to the public independently from the predominant Government's narrative, which reiterated the positive parts only and undermined the negative ones. For a few years already, the EC annual report has not been neither presented nor debated in the National Assembly of the Republic of Serbia and so the parliamentarians did not have the opportunity to discuss the report.

EWB and CDF wanted to offer an alternative forum by inviting members of parliament to a structured dialogue with experts and CSOs activists. It was very important that the analysis of the report on Serbia were prepared quickly so as to come up with the key notes earlier or at least at the same time with the Government. The analysis of the EC reports on other WB countries was done at the same time. The debate was organized in Media Center with participations of ten members of the Parliament. It was very well covered by media and on social networks, which enabled the organizers to present the key EC findings and conclusions to the citizens in a more objective way.

The analyses of the EC reports were presented by Marko Savkovic (BFPE), Katarina Golubovic (JU-KOM), Rasa Nedeljkovic (CRTA), Bojan Elek (BCBP), Nikola Burazer (EWB) and Natasa Vuckovic (CDF).

#### **LAWGEM**

(Erasmus +, started in December 2019, CDF as associate on the project consortium) New quality in Education for Gender Equality - Strategic Partnership for the Development of a Master's Study Program



The initial (i.e. kick-off) meeting related to the implementation of the international scientific project Erasmus Plus KA203 – Strategic Partnership in Higher Education, granted to the University of Belgrade as coordinator, for the specific project named: `New Quality in Education for Gender Equality – Strategic Partnership for the Development of Master`s Study Program LAW AND GENDER` (LAW-GEM) was held at the University of Belgrade Faculty of Law, on 12<sup>th</sup> and 13<sup>th</sup> December.

The initial (i.e. kick-off) meeting related to the implementation of the international scientific project Erasmus Plus KA203 – Strategic Partnership in Higher Education, granted to the University of Belgrade as coordinator, for the specific project named: `New Quality in Education for Gender Equality – Strategic Partnership for the Development of Master`s Study Program LAW AND GENDER` (LAW-GEM) was held at the University of Belgrade Faculty of Law, on 12<sup>th</sup> and 13<sup>th</sup> December. The Vice



Dean for International Cooperation Ass. Prof. Dr Jelena Lepetić had opened the gathering, on behalf of the Management of the Faculty of Law and on behalf of the Dean of Faculty of Law, Prof. Dr Zoran Mirković, who was objectively prevented from attending it. After that Prof. Dr Ivanka Popović, the Rector of the University of Belgrade, greeted the gathering. In addition, the gathering was greeted by the Commissioner for the Protection of Equality Brankica Janković, as the chief representative of the associated partner of the LAWGEM project.

The holder of the aforementioned project is the University of Belgrade and its Faculty of Law, whereas the project coordinator is Prof. Dr Dragica Vujadinović. Along with the University of Belgrade, the members of the Consortium to which the implementation of the project is delegated are, as follows: Lumsa University Palermo, Italy (Libera Universita Maria SS. Assunta di Roma, Department of Law); Orebro University, School of Law, Psychology and Social Work (Örebro universitet), Sweden; University of Saaarland Faculty of Law, Europa Institut (Universitat des Saarlandes), Germany; University of Cadiz (Universidad de Cadiz), Spain.

Representatives of all Consortium members, thirteen in total (four from Spain, and three from Germany, Sweden and Italy), as well as a number of members of the University of Belgrade Faculty of Law research team were present at the initial meeting. All researchers have actively participated in conversations on project implementation, and in particular on the first two sets of intellectual outcomes of the LAWGEM project, which are already being created, and which consist of the curriculum of the Master's programme and the Questionnaire for the empirical study of the academic staff's opinion on gender equality at all Consortium members.

#### **HEALTH AND SAFETY AT WORK IN WB COUNTRIES**

This two-year regional project was completed in 2019 with the final conference Health and Safety at Work – Experience in the WB Countries. The project was implemented by a consortium of 4 organizations, with the CDF as lead partner, Center for Labour Rights from Albania, PEN from Kosovo\* and Center for Civic Action from BiH. Those organizations continuously work on socio economic rights protection, monitoring implementation of the legal framework, and advocacy for policy change.

The Conference was organized in Tirana (February 2019) with participation of CSOs, trade unions, business associations and representatives of the governments and of independent institutions from the WB countries.

The project reiterated the need for regional networks in the field of socio-economic rights and the partners initiated the follow-up design process so as to continue and up-grade the established cooperation.







### **Conclusions**

The year 2019 was very successful for the Center for Democracy Foundation, as the foundations laid in 2018 for further programmatic development were well benefited.

The Foundation marked its 25<sup>th</sup> anniversary through a month-long creative online campaign presenting its development phases, projects implemented and results achieved so far.

The EU values, policies and accession negotiations were the corner stone of the Foundation's standpoints and activities.

Also, the Foundation confirmed its specialization in the field of socio-economic development by editing and publishing of numerous papers, analyses and publications, as well as its representatives participated as keynote speakers at many relevant public events and its partners` projects.

Very good foundation has been set for expanding cooperation with key stakeholders – CSOs in Serbia, in the WB and in the EU member states, which is to be further developed in 2020. Visibility of the Foundation was significantly improved by timely press releases, preparation of presen-

tation material, good placing of analyses, brochures and publications.
